October Mini'app'les Meeting

At the October Mini'app'les meeting, we covered a number of tips and tricks for iOS 7. Here are a few.

- **How to Switch and Close Apps**
One of the more significant changes in iOS 7 is the new way to switch to and close apps running in the background. Instead of an app tray of icons, pressing the home button twice shows previews of apps open in the background as well as those recently used. Tapping once on the window preview or icon will launch the app or swiping up will close the app.
- **Bolder and Bigger Text**
The text in iOS 7 are lighter and thinner than in previous versions. In the Settings app, go to General > Accessibility and you will find an "Increase Contrast" that you can turn on. There is also a "Bold Text" option. You can turn one or both options on, however you like it. There is also a 'Dynamic Type' option that makes text larger in supported apps.
- **Teach Siri to Pronounce Names Better**
If you want to change the way Siri pronounces a particular name, when Siri mispronounces the name, say "you didn't

pronounce that correctly." This will initiate a series of questions to help her get it right.

- **Siri Can Handle Your Calls and many more things**
In addition to her (or now his, if you prefer) new voice, Siri can manage your call log for you. Need to listen to a voicemail? Just ask. Want to call back whoever just rang and you missed? Siri can handle that, too. Just make the request and she (or he) will take care of the rest. When Siri is open, there is a ? in the lower left corner. Tap on that to show a whole series of things that Siri can do.
- **App Background Updates**
Apple has finally allowed for background updates in iOS 7. Of course, if you still want to update your apps manually, you can turn it off in the App Store settings.
- **Messages Provides Time Stamps**
You can now find out by checking its timestamp in the Messages app. Just swipe on over from the right side of any conversation and you'll see when each message came in.
- **Control Center**
Swiping down from the top of the screen brings up the Notification Center, but Apple has added a set of options to the bottom of the screen, too. Just swipe up and you'll reveal the Control Center, a quick-access panel with a bevy of shortcuts to Bluetooth, WiFi and Airplay settings, to name a few. By default, the Notification Center and Control Center are available on the lock screen. If you'd like to turn them off, there is a slider located in each of their respective settings in the Setting app.
- **Customize the Today View**
You can also customize the Today View to a limited extent, something we hope Apple expands on to allow third-party apps to appear here. In Settings > Notification Center again and scroll down to the Today View

section highlighted above. The options are quite limited at present, but unless you really need it we recommend getting rid of the Stocks updates. Not only do few people genuinely need, it drains battery as it has to be kept up-to-date. To change the order of what appears, select 'Edit' and drag the available items up and down.

- Reduce Motion Option

iOS 7 uses a parallax effect to create the perception of depth on your Home screen and elsewhere. When this feature is on, you may notice that your wallpaper, icons, and alerts shift slightly as you move your phone. When setting a wallpaper in Settings > Wallpapers & Brightness, the photo or image will be slightly zoomed and cannot be scaled to fit to the screen. You can change this behavior by enabling Settings > General > Accessibility > Reduce Motion.

- Keeping Tracks on Where You Hangout

iOS 7 keeps a track on where you hang out most, allowing it to cache relevant nearby data, "to provide useful location-related information." Once you've used iOS 7 for a while, go to Settings > Privacy > Location Services > System Services to view a list of where you've been most. If you are worried you can turn this feature off in the same place.

- LED Flash for Notifications

You can make the LED light flash when you have notifications. Go to Settings > General > Accessibility and scroll down to 'Hearing' where 'LED Flash for Alerts' resides.

- Quickly Finding a Photo in Years

To quickly scan the hundreds of images you've taken over a year simply press and hold your finger on the screen and run it over the images you've got. Moving your finger will reveal a quick thumbnail of the pictures you've taken.

- Background App Refresh

If you are trying to save battery life visit this pane in Settings. It determines what apps can refresh their content when on Wi-Fi or a mobile network, or use Location Services. Go to Settings > General > Background App Refresh and select whether you want apps to work in the background or not. You can turn it off completely or limit it by app.

- Mail and Unread Emails

You are now able to see how many unread emails you have in a number of folders. Go to Mail > Mailboxes > Edit and select Unread for the folders you want.

- Search

Drag down in your inbox to reveal a search box. You can now search your entire inbox for a keyword rather than just To, From, Subject. You can also limit your search to All mailboxes or the current mailbox you are in. Furthermore you can also limit it to conversation threads.

- Mail Can Mark All Messages as Read

You can just tap the "Mark All" text at the bottom of your mail list and tell iOS 7 what you want.

- Delete Mail and More

In your inbox swipe right to left on the email in question to reveal a big red delete box. Or you can tap on "More" to show Reply, Forward, Flag, Mark as Unread, Move to Junk, Move Message.

- Safari

Safari has been updated to allow users to swipe left to right on the edge of the screen to go back. As you scroll down a webpage, the bottom Control Center will disappear and the URL omnibox will fade making for a more immersive, full screen, reading experience. Search is now completed via one box like Chrome. When you begin typing into the box,

it displays the top URL you've frequented, suggestions from Google Search or other search engines, and your Bookmarks and history.

At the November Mini'app'les meeting starting at 7:00 p.m., we will look at Mavericks, OS 10.9, and the new hardware Apple recently released.

We will have Q&A time at the end.

- Jony Ive: The man behind Apple's magic curtain by Marco della Cava

The man who designed the iPod ponders the question with furrowed brow.

"That's a good one," says Jony Ive, when asked what he would turn his talents to if Apple no longer required them. There's a long silence, then a whispered, thoughtful and prolonged answer that boils down to one thing. He's not going anywhere.

"Look at that chair, we understand it because its form and function are the same thing, which is how the manufactured world has been for hundreds of years," he says in a soft British accent. "And then incredibly and relatively recently, there's this opportunity but with a set of problems to create objects whose forms don't hint at what they do. And they're packed with incredible sophistication and capability."

Ive twirls his iPhone 5s in his hand, then smiles.

- FAA to allow passenger use of iPhones, iPads & other electronics during all phases of flight by Neil Hughes

The rule change will allow passengers to be able to read e-books, play games, and watch videos during all phases of flight, including landing and takeoff, with very limited exceptions. Previously, passengers had to wait until their plane was at a high enough altitude — 10,000 feet — before they could turn on their devices.

The FAA will require that electronic items, books and magazines be held or put in the seat-back pocket during actual takeoff and landing. Cell phones must be kept in airplane mode or have cellular service disabled, and they will not be able to be used for cellular voice calls.

If a carrier offers Wi-Fi service during a flight, that may be accessed. In addition, short-range Bluetooth connections are also allowed.

- Inside Dropbox's quest to bury the hard drive by Marcus Wohlsen

Drew Houston, the 30-year-old CEO and cofounder of Dropbox, is supposed to be having his Steve Jobs moment. In an auditorium packed with elite coders and Silicon Valley insiders in July, Houston is debuting new features he says will transform Dropbox into the mobile era's answer to the hard drive. This is DBX, the company's first developers conference. It's Houston's bid to convince the software industry to buy into his grand vision—and the Wi-Fi isn't working.

The demo team is trying to show off a digital drawing app that allows you to sketch on your iPad in, say, San Francisco and have the sketch appear simultaneously on a colleague's device anywhere in the world. It was meant to be the centerpiece of Houston's pitch for his ambitious new strategy. Dropbox is known for its supremely useful cloud storage service, which lets you drop files into a folder that can be accessed from any computer. But going forward, the company wants to power a new breed of syncable apps that would let you share any kind of data with anyone across any device. In theory it's an epic shift that would put Dropbox at the center of everyone's digital life, turning it into a powerhouse on the level of Facebook, Google, Amazon, and Apple. But it's hard to see that when the demo doesn't work.
